### What is a Webinar?

A Webinar is an on-line conference that uses your computer to deliver audio-visual information during a live workshop and to interact with presenters. If you participate in "real-time" you will have the opportunity to ask questions. Webinars will also be recorded and placed on the One Health Commission website, so if you miss the real-time presentation, you may watch the Webinar at your convenience.

### What are the benefits of a Webinar?

- Cost efficient way to engage when finances for travel are limited
- Quality professional development at your desk
- Multiple attendees from any single location
- All you need is a computer with an internet connection
- Real-time presentations and recorded presentations
- Audio and visual simultaneous presentation
- Q & A during presentation
- Follow-up postings on the OHC website
