Connecting, Creating, and Educating through One Health Ambassadors

It wasn't until I was searching for a master's degree program that I was introduced to the concept of One Health. I quickly realized that I already subscribed to the underpinnings of One Health, but was previously unfamiliar with the term and the movement attached thereto. Now that I am working towards an MSc in One Health, I discuss "OH" with my classmates and with other professionals already involved with One Health with ease, but have received many a confused look when I use the term "One Health" in conversation with even my most environmentally aware acquaintances.

I feel that many current One Health "Outreach" measures, including conferences, websites, and other planned "One Health Events" cater to an audience that is already at least somewhat familiar with One Health. There is a large receptive audience that is not being reached. The creation of a One Health Ambassadors Action Team could help to cover this gap while advocating for, raising awareness of, promoting, and advancing One Health.

I thought of this idea while attending the American Society for Clinical Laboratory Scientists (ASCLS) Wisconsin Convention. Presentations included talks on emerging pathogens, several zoonotic diseases, and a lecture discussing the similarities and differences between human and veterinary medical diagnostics. Many of the poster presentations also contained One Health themes. I feel this would have been a great venue to have a One Health booth among the exhibitors to reach both the professional and student attendees.

I envision the Ambassador team being composed of both professionals and students able to present at a level appropriate for a variety of audiences. Literature and other One Health exhibit materials could be designed for target audiences at the level of elementary school Earth Day celebrations up through professional conventions. The work of many of the other OHC Action Teams, such as the Communications, Education, and Professional Writing Teams would surely compliment the efforts of an Ambassador Team.

The projected costs for creation of a One Health Ambassador Team would include exhibitor fees for events, travel costs, and costs of booths, banners, and any "give away" materials such as pamphlets and pencils. These costs could be mitigated by connecting with new One Health Commission donors at events. It is also possible that some of the expense could be covered through grants or sponsorships, with those grants offered by the Bill and Melinda Gates Foundation being an option.

The success of a One Health Ambassadors team could be evaluated by several metrics, including OHC sponsorship trends, monitoring of the creation of new One Health Related student and community groups, tracking of website traffic trends, and surveys conducted during and/or after each event. I would love to see Ambassador team grow to the point where event planners are contacting the Commission, inviting the One Health Commission to participate based upon Ambassador Team reputation and event attendee interest.
