## Message From the Executive Director



#### Call for One Health Narratives......

There are *many* One Health success stories out there in the hearts and minds of One Health advocates. The Commission wants to spotlight them to 'teach by example'. These can be scientific Case studies or just 'narratives / stories' of how a One Health approach made a difference in public health and/or private lives. Here is one taken from the writings of Veterinarian and Cartoonist Robert Miller about his daughter, a travel writer. When he wrote and published this piece for  $\underline{DVM360}$  magazine back in 2011 (this is an excerpt), he may not have been thinking specifically about One Health. But his daughter's story is an excellent 'missed chance' One Health narrative and teaching tool.

## "She spent a month in Ecuador on assignment

and, while there, ran the Amazon and climbed a 20,000-ft volcano. She came home covered with insect bites and, two weeks later, had swollen and painful joints, fever, skin lesions, and discolored fingernails. She was also short of breath, and radiographs revealed lung lesions. A scan (the first of 10) showed visceral lesions.

At this point, I went to a veterinary conference, and, while I was sitting with three colleagues, I described my daughter's syndrome. Two of the veterinarians said they thought it sounded like bartonellosis or histoplasmosis. The third asked if they have Lyme disease in Ecuador.

A long-time friend and colleague, Dr. Alice Villalobos, joined us and asked what we were talking about. I told her, and she said, "She almost surely has a parasitic or a vector-borne disease. She should take two doses of ivermectin and go on doxycycline for two weeks. Don't wait for a diagnosis."

I passed this on to my daughter, who by this time was being shunted from one specialist to another, nearly all of whom could not relate her syndrome to her trip to South America. Nearly two years and 76 specialists later, she had been erroneously diagnosed with Hodgkin's lymphoma *and* non-Hodgkin's lymphoma. She had been told by dermatologists that she had scabies and sclero-derma. Most of this was at a university medical school.

I contacted Dr. Edward Breitschwerdt, a professor at the North Carolina State University School of Veterinary Medicine. He is one of the world's leading authorities on bartonellosis. He requested a blood test. My daughter's doctors deferred but eventually complied. The test results were positive for *Bartonella vinsonii*.

Meanwhile, a laparotomy was advised because by the this time the presumptive diagnosis was gastrointestinal stromal tumor (GIST), most likely sarcoma.

The surgeon called me from the OR where they had removed a variety of visceral lesions.

"I know you are concerned," he said. "The pathologist's report here in the OR is that there is no evidence of malignancy."

"I never thought she had a malignancy," I replied. "She has bartonellosis."

"I'm a surgeon," he said. "I don't know what \*bartonellosis is."


How much pain, suffering, and *money*, spent on diagnostics and specialists, could have been saved had the physicians seeing his daughter early on been aware of the newly emerging literature on bartonella; had they known 'to' and 'how to' look for it. What if the radiologists reading finding the granulomatous lesions, had been aware that such lesions could be caused by this bacteria. Or what if the surgeon had known to submit some of those lesions for bartonella testing by the most sensitive and specific methods available. And here is an even harder question. Now that there 'is' a multitude of evidence about this 'stealth' pathogen and excellent diagnostic techniques to find it, how are busy physicians to *ever* hear about it since much of the information is coming out of the veterinary domain? We don't go to each other's continuing education conferences (indeed it is very difficult to make this happen). Think about it. That is what the One Health conversation can provide: forums, opportunities, occasions, ways, 'means' for us to get together across disciplines to explore and share information. And oh, by the way, what are the environmental components of this story? Had there been major deforestation or other changes in the regions where she visited that increased the infected mammal numbers or insect burden and thus the likelihood that she and many others would be infected. And, even sadder, how many people living in those regions are being sickened as you read this by this pathogen that not even medicine in the most developed world is recognizing, diagnosing and treating? There is a lot more narrative to the bartonella story so maybe we'll revisit it at another time.

My message to you today is that collaborations and information exchange don't just magically happen. They start with *relationships*. And relationships don't just 'happen', they start when we *meet* and *talk with* each other. That is what we must figure out how to do, And we can...if we really want to.

# **OHC Recent Happenings**

## **OHC Board Structure being revised to better reflect One Health Domains**



The Board of Directors agreed during discussions in 2014 that there was intense need to bring representation from all One Health domains into OHC leadership to better reflect the face of One Health. Therefore the Board structure is being altered to encourage representation of *all* One Health domains, animal (domestic and wild), human, environmental and plant. Institutions that sponsor the Commission at the 'Leader' level (\$5,000 / year) will continue to nominate a representative to the OHC Board of 'Financial, In Kind, and Ex Officio' Sponsors. That group will elect an <u>Executive Board</u> voting body of 20 or less (not to be confused with the Executive 'Committee' comprised of Chair, Vice Chair, Past Chair, Treasurer and Secretary) that will oversee OHC business. The <u>Executive Board</u> will be comprised of 3 representatives from each One Health domain plus 3-5 'At Large' representatives invited by the Executive Board as needed (example media/public relations, legal, development expertise) and 2-3 voting student representatives from at least 2 different One Health domains elected by students and approved by the Executive Board. Executive

Board members must meet a set of requirements for participation and will provide an Alternate to attend Board meetings on their behalf when the primary Board member cannot be present. It is the Board's responsibility, as Leaders of the Commission, to assure that the above needs are met and to help locate the needed funding to sustain this non-profit organization that has so much to offer the One Health movement. By-Laws are being updated.

#### **One Health Commission and One Health Initiative Pro Bono Website Team Partnering**

*January, 2015* In a joint letter to the AVMA Executive Board and staff, the One Health Commission (OHC) and the One Health Initiative (OHI) Autonomous pro bono Website Team announced mutual support and collaborations over the past year. Each organization – the One Health Initiative and the One Health Commission - has its own unique contributions to make to advance the One Health agenda. We recognize that our combined impact will be greater working in unison than if we operate independently. The OHC and OHI have recognized each



group's contributions to a shared One Health agenda on their respective websites and have established bilateral links to news items, events and publications of interest to One Health stakeholders. One Health information and announcements are being shared freely between the teams. This liaison was noted in the Journal of the American Veterinary Medical Association (JAVMA) recently published <u>article in the April 1, 2015 issue</u>, 'Senators, academics, others embrace one-health approach' by Katie Burns.



#### First International Who's Who in One Health Webinar

The One Health Commission was pleased to host the 1st International Who's Who in One Health Webinar on November 10, 2014. This Webinar brought together noted One Health leaders, advocates, professionals and students in real-time to discuss global One Health efforts while providing a forum for dialogue within and across disciplines. There was no cost to attend the Webinar but participants had to register in advance. The objectives of the Webinar were to:

- Connect One Health stakeholders around the world to better understand, share and highlight individual- and agency-level efforts;
- Educate Webinar participants about the One Health paradigm and way of thinking towards improved health outcomes; and
- Create new strategic partnerships and networks for collective, purposeful and coordinated actions






Total attendance for the webinar was estimated at 1007 individuals from 41 countries. Of those, 51.4% represented the animal health domain, 18.1% the human health do-

main, and 2.8% the environmental health domain; 42.6% were from academia, 19.1% from government, 13.1% from not-for-profit organizations and 8.4% from private, for-profit organizations. Of the nine statements used to evaluate the webinar, participants rated all nine very highly (4.19 to 4.79 on a scale of 1 to 5), indicating enthusiastic reception and strong support for this and future webinars. When participants were asked 'Which One Health domain to you primarily work in?', 20.5% indicated that they worked in All Domains, 51.4% worked in the Animal Domain, 18.1% in the Human Domain, 2.8% reported working in the Environmental Domain. 0.4% reported 'other', 6% reported 'unknown domain', and 0.8% indicated 'N/A'.



When participants were asked to indicate their work arena / setting, 42.6% were from academia, 19.1% worked in government, 13.1% worked in the non-profit sector, 8.4% in the Private, For Profit sector with 6.4% indicating that the question was N/A and 6.8% indicating 'arena unknown'.

Executive Director, Dr. Cheryl Stroud, represented the One Health Commission at the <u>Third Inter-</u> <u>national One Health Congress</u> in Amsterdam, The Netherlands, from March 15-March 18, 2015. The theme of the conference was '*Prevention at the Source is key to controlling (infectious) diseases that have a growing impact on humans, animals and their ecosystems.*' You can view the conference's <u>opening video</u>. Dr. Stroud presented a <u>poster</u> on the Commission's activities to '*Connect, Create, Educate*' and met with many international One Health leaders. She was joined by OHC Board member Tammi Krecek, DSc, who was there representing Texas A&M University's extensive One Health program.

In addition to delivering the poster presentation, Dr. Stroud was invited to speak at a <u>Roundtable</u> discussion (sponsored by Zoetis) that addressed the topic "Partnering between Human and Animal Research to

support One Health Innovation". The objective of this noon discussion was to investigate how partnerships between human and animal research groups, both private and public, can help advance key One Health topics and to identify subjects of common interest that will benefit both domains. Also presenting on the panel was Ab Osterhaus, Utrecht University Vet School, the Netherlands, CEO of the Artemis One Health Foundation and Co-Manager of the international One Health Platform Foundation, Professor David Hume, Director of the Roslin Institute, U.K., and Dr. Thiery Pineau, Head of Animal Health Division at INRA, France. Excellent dialogue was shared and seeds planted for future 'collaborations'.

# The White House

On February 12, 2015, seven U.S. Senators sent a letter to President Obama urging the creation of a U.S. Framework for One Health and a U.N. Inter-Agency Framework for One Health. The One Health Commission and One Health Initiative teams joined forces to share the excellent news. This letter was developed in the office of Sen. Al Franken (Minn.) with the assistance of Dr. Chase Crawford, a veterinarian (recent TAMU grad) who is serving as an AVMA Congressional Fellow in Mr. Franken's office.

Other senators signing were Christopher Coons (Delaware), Kirsten Gillibrand (New York), Mark Warner, (Virginia), Dianne Feinstein (California), Michael Bennet, (Colorado) and Tim Kaine (Virginia). The One Health Commission sent online letters of congratulations and thanks to each senator's office and started an email campaign encouraging all

One Health stakeholders to do the same. The Commission is currently entertaining the idea of sending its own letter to the White House with specific suggestions for what a U.S. One Health platform might look like inviting all who are interested to sign onto the letter.

## White House (invitational) One Health Symposium on Antimicrobial Resistance, May (date not yet determined), 2015

A White House One Health Symposium will bring together public health and animal agriculture communities to discuss advancement/compliance with the National AMR Strategy released late last year. The focus of the symposium is to engage the collective public/animal health communities in the issues of education/outreach initiatives,

#### **NIH One Health Workshop**

April 7-8, 2015, One Health Workshop: Integrating the Veterinarian Scientist into the Biomedical Research, Lister Hill Auditorium, NIH . The Office of Research Infrastructure Programs (ORIP) within the Division of Program Coordination, Planning and Strategic Initiatives sponsored an NIH One Health Conference on April 7-8 that brought together veterinarians, clinicians and basic researchers.

> The aim of this conference was to provide information and advice on how basic and applied biomedical research, utilizing the concept of One Health, can advance the NIH mission relative to human health and disease. Participants discussed case studies in which multidisciplinary teams combine investigations using both animal and human subjects to study various conditions, including infectious disease,

cancer and neurological disease, among others. Participants discussed examples of training programs that utilize the One Health concept and that will identify best practices for training veterinarian scientists to be part of interdisciplinary biomedical research teams. Participants and attendees provided input on how the NIH might further its mission by incorporating the One Health concept into research and training programs. ORIP funds animal-based resources and research projects, playing a central role at the NIH for training veterinarian scientists. ORIP seeks advice regarding future directions for its programs, including alignment with recommendations from the 2014 NIH Physician-Scientist Workforce Working Group Report and initiatives being planned by veterinary schools to partner with NIH funded Clinical and Translational Science Centers and other Resources. ## **Update on One Health Action Teams**

- 1. <u>Communications Team</u> "Educate"

This multidisciplinary team is creating. a series of One Health Public Service Announcement (PSA) radio shorts for distribution to radio stations across the U.S. The first one, 'What is One Health?' is ready for release (and can be viewed on the OHC website... need link). Additional topics planned are two infectious disease topics, one ecosystem topic, and one food safety topic. Future proposed topics include Lyme disease, Bat Rabies, Salmonellosis (food safety).



2. <u>General One Health (non CE) Webinars</u> <u>Team – "Educate"</u>

Participate and provide guidance in the creation and carrying out of online general, non-CE, One Health webinars. One Health Commission staff will provide Webinar platforms and support. The First International Who's Who in One Health Webinar hosted last November was just the beginning.

#### 3. <u>Professional CE/CME Team – "Connect, Educate"</u>

This group is creating a 3-5 session, multidisciplinary CE/CME webinar series on One Health Issues titled **"Significance of One Health for Veterinary and Human Health Practitioners".** This series is targeted jointly to human and veterinary 'clinical' health practitioners. The first two proposed topics include 'Asthma and Allergies in People and Pets- Environmental Influences' and 'Bartonelosis in people and pets: it's more than cat scratch fever."

#### 4. <u>Website Support Team</u> - "Educate" and "Connect"

This team supports the OHC in gathering and posting up to date information on the website. The members are also involved with the 2015 website expansion creating a strong site for One Health activities and information around the globe

6. IOM Workshop/Study Team - "Connect, Educate"

This team is working to facilitate an IOM study (full consensus, mini consensus or workshop) on gaps in One Health Education in professional health education across Veterinary, Human, Public Health and Environmental Health educational settings

#### 7. <u>Professional Writing Team</u> – "Educate"

This Team will identify and write One Health white papers and professional articles for submission to peer reviewed journals. It will strive to represent all One Health domains with authors and topics. An initial Team is forming for a paper on 'The Economic Value of a One Health Approach'

8. <u>One Health Education Team</u> – "*Educate*" - Identify and distribute One Health educational materials

**# 1 Initiative: Bat Rabies Poster Distribution Team** These bat raboes edicational posters were created in partnership with the Global Alliance for Rabies Control and Bat Conservation International. Help us get the bat rabies educational posters (children 12 and under and adults) into the schools of primary and secondary students, into public health and emergency departments and post offices around the country and world, posted on hiking trail heads etc...and wherever seems helpful to educate about bat rabies, still a killer in the Americas.

**#2 Initiative: One Health Coloring Books for school age children** – this team will create a Coloring Book competition for Students for One Health to create coloring books about One Health issues that are appropriate for K-third grade children. – in planning.

**#3 Initiative: Team to fund and place the <u>textbook</u> <b>'Zoonosis: Protecting People and Their Pets' into the hands of medical, veterinary and public health students.** – in planning.

#### 9. <u>One Health Narratives Team</u> – "Educate"

Identify and collect One Health stories to demonstrate the importance and value of a One Health Approach and teach by example. These can be either scientific Case Studies or well-grounded anecdotal examples.

#### 10. Legislative Watch Team - "Educate"

Monitor and identify important legislative initiatives at the International, National and State level that will impact any One Health domain(s) or issues. Example: Antibiotic Resistance, climate change and disease. As a 501c3 non-profit, the Commission can do very little active 'lobbying'. It can, however, educate government staff.

#### 11. <u>One Health Library Team</u> – "Educate"

Provide guidance, expertise and assistance in the creation and maintenance of a searchable, online, One Health Library on the OHC website.

#### 12. <u>One Health in the News Team</u>- "Educate"

Provide assistance in identifying and crafting information to keep the One Health community abreast of developing information, in partnership with NC OHC One Health News Bits.
