Description and Scope of One Health Activities The One Health Commission is a globally focused 501(c)(3) organization, chartered in Washington, D.C., dedicated to promoting improved health of people, domestic animals, wildlife, plants and the environment. It seeks to educate all audiences about the importance of transcending institutional and disciplinary boundaries, and transforming the way that human, animal, plant, and ecosystem health professionals, and their related disciplines, work together to improve the health of all living things and the environment.

The OHC operates under the motto 'Connect, Create, Educate' as it connects One Health stakeholders to join hands to create teams that will educate about One Health thus fulfilling its charter / mission:

To 'Educate' and 'Create' networks to improve health outcomes and well-being of humans, animals and plants and to promote environmental resilience through a collaborative, global One Health approach.

The OHC is composed of individuals, institutions and corporations that believe in and want to help support its work toward a One Health 'paradigm shift' that will make transdisciplinary, One Health thinking the 'default' way of doing business.
