

OHSC was established to improve intra-agency and interagency communication and cooperation on public health issues requiring a cross-agency focus in the One Health arena. In partnership with the Offices of the Commissioner and the Centers within the Agency, the FDA One Health Steering Committee provides collaboration and support for the Agency's One Health work.
